Licensed Building Surveyor (Class II)	(a) A bachelor degree in Civil / Construction Engineering from a Government recognized University or an equivalent engineering qualification recognized by the Government and may have not less than two years experience in planning, design and execution of building works including sanitary and plumbing works related to the building in areas other than the municipalities in hill areas. OR (b) A Diploma in Civil Engineering or Architecture from a Government recognized University or an equivalent engineering qualification recognized by the Government and may have at least five years experience in planning, design and execution of building works including sanitary and plumbing works related to building in areas other than the municipalities in hill areas.
II.	Licensed Building Surveyor (Class I)	(a) A bachelor degree in Civil / Construction Engineering from a Government recognized University or an equivalent engineering qualification recognized by the Government and may have not less than five years experience in planning, design and execution of building works including sanitary and plumbing works related to building in areas other than the municipalities in hill areas. OR (b) A Diploma in Civil Engineering or Architecture from a Government recognized University or an equivalent engineering qualification recognized by the Government and may have at least ten years experience in planning, design and execution of building works including sanitary and plumbing works related to the building in areas other than the municipalities in hill areas.
